whole of the 12 months prior to your application?	
Have you had your only or main place of work in the parish of Nowton for at least	
the whole of the 12 months prior to your application?	

Disqualifications – You must be able to answer 'No' to all of the questions below to be eligible to serve as a Parish Councillor:

Are you the subject of a bankruptcy restrictions order or interim order?	
Have you, within the last five years, been convicted of an offence in the UK, the	
Channel Islands or the Isle of Man which resulted in a sentence of imprisonment	
(whether suspended or not) for a period of three months or more without the	
option of a fine?	Yes / No
Are you disqualified by order of a court from being a member of a local authority?
